CONTINUITY OF CARE ENROLMENT AT WOODMANSEY CE PRIMARY SCHOOL PHASE 4 SECOND SUMMER HALF TERM

"As a country, we all need to do what we can to reduce the spread of the COVID-19 virus." That is why the government has given clear guidance on [self-isolation](#), [household isolation](#) and [social distancing](#).

Schools are, being asked to continue to provide care for children who are vulnerable and [children whose parents are critical to the Covid-19 response](#). **If workers think they fall within the critical categories above, they should confirm with their employer that, based on their business continuity arrangements, their specific role is necessary for the continuation of this essential public service.**

Vulnerable children include children who are supported by social care, those with safeguarding and welfare needs, including child in need plans, on child protection plans, 'looked after' children, young carers, disabled children and those with [education, health and care \(EHC\) plans](#).

Parents whose work is critical to the COVID-19 response include those who work in health and social care and in other key sectors overleaf.

Those in these categories above are being asked to complete the following form, in order to register that their child(ren) are eligible for this provision. It is no longer the case that children in the listed categories should be at home if care can be provided there. However, it may be possible that the school capacity will be breached if every child in these keyworker categories attends school full time. Please note that now or if in the future your child's year group has returned to school, that child will be expected to attend school with that year group full time (or as agreed with nursery sessions).

Full arrangements for the safe access to school including the times for the school day which will be changing for different cohorts will be published shortly. The key workers school day will be from 8:15am to 3:45pm. **We cannot however, safely staff the Breakfast and After-School Club so this offer is currently suspended until further notice.**

To all Key Workers, may we add our thanks to you for all you are doing to look after us, care for us, feed us, support us and keep us safe. You are Brilliant.

- I also understand that the following still applies regarding the need to self-isolate.

The symptoms are a persistent cough and/or a high temperature and/or a loss of sense of taste and/or a loss of sense of smell.

Once you have informed the school that your household is self-isolating, your child cannot return to school until 14 days from the first date of absence. It is not possible to change your mind. If a child is self-isolating because of another household member but then develops the symptoms, then the self-isolation of that individual is then seven days from the start of the symptoms. Once a parent has informed the school that a child is to be kept at home through self-isolation, there is no need to telephone everyday through that period.
